## NOTES ON THIS PROXY FORM:

- 1. A Creditor may insert the name of a proxy or the names of two alternative proxies of his/her choice in the space provided, with or without deleting "the business rescue practitioners ("BRPs") who act as the Chairmen of the Meeting of Creditors". The person whose name stands first on the form of proxy and who is present and voting at the Meeting of Creditors will be entitled to act as proxy to the exclusion of those whose names follow.
- 2. The form of proxy must be:
  - 2.1 submitting it via email, to the Company's business rescue email address at: <u>BR@tongaat.com</u> by no later than **17H00 on Thursday 7 September 2023**; or
  - 2.2 delivering it by hand, to the Company's registered business address located at: Amanzimnyama Hill, Tongaat, KwaZulu-Natal, 4400, South Africa - by no later than **17H00 on Wednesday 6 September 2023**.
- 3. The completion and lodging of this form of proxy will not preclude the relevant Creditor from virtually attending and participating in the Meeting and voting thereat, to the exclusion of the proxy appointed in terms thereof, should such Creditor wish to do so.
- 4. If this proxy is signed under power of attorney or by a representative on behalf of a company, close corporation or trust, it must be accompanied by an appropriate power of attorney (for an individual) or authorising resolution/letter (for a juristic person) as is applicable giving such representative the authority to act as proxy and vote at the First Meeting.
