# REPORT ON THE STATUS OF THE BUSINESS RESCUE PROCEEDINGS OF VOERMOL FEEDS PROPRIETARY LIMITED (IN BUSINESS RESCUE) ("Company")

# 1. <u>GENERAL</u>

- 1.1. In accordance with section 132(3)(a) and section 132(3)(b) of the Companies Act 71 of 2008, as amended ("Act"), when the business rescue proceedings of a company have not concluded within 3 months of the date on which they started, a business rescue practitioner is required to-
  - 1.1.1. prepare a report on the progress of the business rescue, and update it at the end of each subsequent month until the end of the business rescue proceedings; and
  - 1.1.2. deliver the report and each update to each affected person and to the Companies and Intellectual Property Commission ("**CIPC**").
- 1.2. Accordingly, we hereby provide you with the seventh report, being the September 2023 report, on the status of the Company's business rescue proceedings.

#### 2. <u>BUSINESS RESCUE UPDATES</u>

Affected Persons are reminded that the Company's business rescue proceedings are inextricably linked with those of Tongaat Hulett Sugar South Africa Limited (in business rescue) ("**THSSA**") and Tongaat Hulett Ltd (in business rescue) ("**THL**"), the Company's ultimate parent and legal "principal." This is due to the fact that the Company has operated as an agent for a previously undisclosed principal, THSSA, noting that THSSA operated as an agent for a previously

undisclosed principal, THL. As a result, the business rescue proceedings of the Company are wholly dependent on the business rescue proceedings and business rescue plan of THSSA, which.

The following matters have occurred or remain relevant since the distribution and publication of the Company's August 2023 business rescue status update report (**``August Report**"):

# 2.1. Extension of the publication date of the Amended Business Rescue Plan and further adjournment of the meeting in terms of section 151 of the Act

- 2.1.1. The process to finalise the transaction details with regard to THL's Strategic Equity Partner ("SEP") process was taking longer than anticipated. As a result, it was deemed necessary to extend the date for the publication of THL's amended business rescue plan and as such, the amended Business Rescue Plan ("Plan") for the Company and further adjournment of the Company's meetings to be held in terms of section 151 of the Act ("Meeting").
- 2.1.2. Accordingly, the BRPs convened a virtual meeting of Creditors on 08 September 2023, to seek the approval of Creditors for the extension of the date for the publication of the Plan to no later than 31 October 2023, and the further adjournment of the Meeting to no later than 30 November 2023.
- 2.1.3. Pursuant to this meeting, the requisite majority of Creditors' voting interests voted in favour of the motions to:
  - Extend the date for the publication of the Plan to a date no later than 31 October 2023; and
  - Adjourn the Meeting to a date no later than 30 November 2023, and no less than 30 days' prior written notice of the intended date of the Meeting being provided to Creditors.

# 2.2. Business Rescue Proceedings of other Tongaat Hulett Group Entities

- 2.2.1. The amended business rescue plans for THL and THSSA, will be published at a similar time as the Company's Plan.
- 2.2.2. The adopted business rescue plan for Tongaat Hulett Developments Proprietary Limited ("**THD**") as published on Friday, 19 May 2023 continues to be implemented.
- 2.2.3. Separate monthly status update reports are provided for THL, THSSA and THD which



reports are uploaded and made accessible to Affected Persons on the THL website at: <u>www.tongaat.com</u>, under the 'Business Rescue' tab.

# 2.3. Creditor Claims

2.3.1. Post the publication of the Plan, we have not received any further claims against the Company. Thus, the process of claim verification and the reconciliation of creditor claims against the Company is currently up to date. Creditors are reminded that all claims lodged against the Company, which are accepted in whole or in part, will be reflected in the amended business rescue plan. The amended business rescue plan will provide a process for Creditors to deal with any remaining disputes related to claims and Creditors who dispute their claims reflected in the amended business rescue plan, will be at liberty to follow such process, if they so wish.

# 3. CLOSING REMARKS

- 3.1. It remains our view that with your continued assistance and co-operation, the Company stands a reasonable chance of being rescued, within the meaning of section 128(1)(h) of the Companies Act, in a manner that will balance the rights and interests of all Affected Persons.
- 3.2. Affected Persons are reminded that all notices and documents regarding the business rescue proceedings of the Company that have been and/or will be circulated to all known Affected Persons are or will be published and made available to all Affected Persons on the THL website at: <a href="http://www.tongaat.com">www.tongaat.com</a>, under the 'Business Rescue' tab.
