REPORT ON THE STATUS OF THE BUSINESS RESCUE PROCEEDINGS OF VOERMOL FEEDS PROPRIETARY LIMITED (IN BUSINESS RESCUE) ("Company")

## 1. **GENERAL**

- 1.1. In accordance with section 132(3)(a) and section 132(3)(b) of the Companies Act 71 of 2008, as amended ("Companies Act"), when the business rescue proceedings of a company have not concluded within 3 months of the date on which they started, a business rescue practitioner is required to-
  - 1.1.1. prepare a report on the progress of the business rescue, and update it at the end of each subsequent month until the end of the business rescue proceedings; and
  - 1.1.2. deliver the report and each update to each affected person and to the Companies and Intellectual Property Commission ("CIPC").
- 1.2. Accordingly, we hereby provide you with the eighth report, being the October 2023 report, on the status of the Company's business rescue proceedings.

### 2. BUSINESS RESCUE UPDATES

Affected Persons are reminded that the Company's business rescue proceedings are inextricably linked with those of Tongaat Hulett Sugar South Africa Limited (in business rescue) ("THSSA")



and Tongaat Hulett Ltd (in business rescue) ("**THL**"), the Company's ultimate parent and legal "principal." This is due to the fact that the Company has operated as an agent for a previously undisclosed principal, THSSA, noting that THSSA operated as an agent for a previously undisclosed principal, THL. As a result, the business rescue proceedings of the Company are wholly dependent on the business rescue proceedings and business rescue plan of THSSA.

The following matters have occurred or remain relevant since the distribution and publication of the Company's September 2023 business rescue status update report ("**September Report**"):

# 2.1. Section 151 Meeting Date and Extension of Date for Publication of Amended Business Rescue Plan

- 2.1.1. At a meeting of creditors held on 8 September 2023, ("September Meeting") the requisite majority of creditors agreed to an adjournment of the meeting ("151 Meeting") to be held in terms of section 151 of the Companies Act, to consider and, if appropriate, approve the Company's amended Business Rescue Plan, to no later than 30 November 2023 and that no less than 30 days' prior written notice of the intended date of the adjourned 151 Meeting must be provided to Creditors
- 2.1.2. At the September Meeting, the requisite majority of creditors agreed to an extension of the date for the publication of the Company's amended Plan to no later than 31 October 2023. The finalisation of the relevant transaction(s) to be incorporated into the amended Business Rescue Plan of THL is taking longer than previously anticipated. As a result, creditors were requested and consented to an extension of the date for publication of the amended Business Rescue Plan to no later than 24 November 2023 as well as the application of the notice periods as detailed in S151(1) and (2) of the Companies Act.
- 2.1.3. On 6 October 2023, the Business Rescue Practitioners issued a notice convening the 151 Meeting and for the 151 Meeting to be held on 7 November 2023. In light of the extension of the date for publication of the amended Plan, the 151 Meeting will not be held on 7 November 2023 and the prior notice was withdrawn. Instead, the 151 Meeting will be held no later than 30 November 2023, in accordance with the agreement of creditors at the September Meeting. An updated 151 Meeting date will be shared as soon as possible in the coming days.



## 2.2. Business Rescue Proceedings of other Tongaat Hulett Group Entities

- 2.2.1. The amended business rescue Plans for THL and THSSA, will be published at a similar time as the Company's Plan.
- 2.2.2. The adopted business rescue Plan for Tongaat Hulett Developments Proprietary Limited ("**THD**") as published on Friday, 19 May 2023 continues to be implemented.
- 2.2.3. Separate monthly status update reports are provided for THL, THSSA and THD which reports are uploaded and made accessible to Affected Persons on the THL website at: <a href="https://www.tongaat.com">www.tongaat.com</a>, under the 'Business Rescue' tab.

## 2.3. Creditor Claims

2.3.1. Post the publication of the Plan, we have not received any further claims against the Company. Thus, the process of claim verification and the reconciliation of creditor claims against the Company is currently up to date. Creditors are reminded that all claims lodged against the Company, which are accepted in whole or in part, will be reflected in the amended Business Rescue Plan. The amended Business Rescue Plan will provide a processfor creditors to deal with any remaining disputes related to claims and creditors who dispute their claims reflected in the amended Business Rescue Plan, will be at liberty to follow such process, if they so wish.

## 3. **CLOSING REMARKS**

- 3.1. It remains our view that with your continued assistance and co-operation, the Company stands a reasonable chance of being rescued, within the meaning of section 128(1)(h) of the Companies Act, in a manner that will balance the rights and interests of all Affected Persons.
- 3.2.
