## NOTICE TO AFFECTED PERSONS RE: ADJOURNMENT OF SECTION 151 MEETING IN THE BUSINESS RESCUE PROCEEDINGS OF VOERMOL FEEDS PROPRIETARY LIMITED (IN BUSINESS RESCUE) ("Company")

- 1. As previously advised, the Company's business rescue proceedings are inextricably linked with those of Tongaat Hulett Limited (in business rescue) ("THL"), the Company's ultimate parent and previously undisclosed legal "principal". This is due to the fact that the Company has operated as an agent for its previously undisclosed principal, being Tongaat Hulett Sugar South Africa Proprietary Limited ("THSSA"), noting that THSSA operated as an agent for THL as its previously undisclosed principal. As a result, the business rescue proceedings of the Company are wholly dependent on the business rescue proceedings and business rescue plan of THL.
- On 13 December 2023, the Court had ordered, *inter alia*, the adjournment of the meeting of THL ("THL 151 Meeting"), which was to be held in terms of section 151 of the Companies Act, to consider and, if appropriate, approve the THL's amended Plan, from Thursday, 14 December 2023 to a date no later than 11 January 2024.
- 3. The THL 151 Meeting was reconvened on 10 January 2024, however the section 152(2) vote has not yet taken place and therefore the THL 151 Meeting has not yet been concluded. Accordingly, the BRPs seek the approval of creditors by way of proxy for the adjournment of the Company's 151
