



state under oath as follows -

- 1 I am a duly admitted legal practitioner conducting the practice of an attorney as envisaged by the Legal Practice Act No. 28 of 2014, and a director of Werksmans Attorneys Incorporated ("**Werksmans**") situate at The Central, 96 Rivonia Road, Dennehof, Sandton. Werksmans is the attorneys of record for the applicants, ("**the applicants**").
- 2 The matters I traverse in this affidavit are, to the best of my knowledge, both true and correct. They are also within my personal knowledge. - except where it is apparent from the context that they are not.

**PURPOSE**

- 3 On 15 December 2025, the Supreme Court of Appeal delivered its judgment in the above matter, and in respect of which an application for leave to appeal has been delivered to this Honourable Court. Taking into account the *dies non*, the applicant was required to file its application for leave to appeal to this Honourable Court on or before 5 February 2026.
- 4 The purpose of this application is to seek condonation for the late filing of the applicants' Notice of Application for Leave to Appeal to the Constitutional Court.

("the Application"). Through a bona fide administrative error, the application was delivered on 6 February 2026, having been first sent to an incorrect email address on 5 February 2026.

## THE FILING OF THE APPLICATION

- 5 At approximately 15h30 on 5 February 2026, the Application was inadvertently emailed by me to the following address - [generaloffice@concourt.org](mailto:generaloffice@concourt.org). A copy of this email is annexed marked "TJB1".
- 6 Shortly thereafter, I received a delivery receipt from Microsoft Outlook confirming that delivery of my email was "complete". A copy of this email is annexed marked "TJB2".
- 7 I thereafter delivered a further email which contained an updated index and bundle of further service emails. The recipient's email address was auto filled and unfortunately, was similarly transmitted to the email address set out in 5 above in error. A copy of this email is annexed marked "TJB3".
- 8 Having received, the delivery receipt referred to above, I did not follow up to confirm receipt of my emails following their transmission because it is my understanding that it can take up to 48 hours for this Honourable Court to register an application for leave to appeal and issue a case number.

9 At approximately, 10h30 on 6 February 2026, I requested my co-director, Ms Daniela Pisanti-Hatiras (nee Pisanti) ("Ms Pisanti"), to contact the Registrar of this Honourable Court to ensure that the Application had been received.

10 Ms Pisanti contacted the general office number for the above Honourable Court and was advised to contact the Registrar, Ms Mthethwa, on her direct telephone number.

11 Ms Pisanti was not able to reach Ms Mthethwa and consequently sent an email to the above Honourable Court using the following email address - [generaloffice@concourt.org.za](mailto:generaloffice@concourt.org.za), in which she requested confirmation that the application had been received. A copy of this email is annexed marked "TJB4".

12 Thereafter, Ms Pisanti again contacted Ms Mthethwa and enquired whether she had received her email ("TJB4") and my emails of 5 February 2026 ("TJB1" and "TJB3").

13 Ms Mthethwa indicated that she had not received any email from Werksmans and requested Ms Pisanti to forward her email ("TJB4") [mthethwa@concourt.org.za](mailto:mthethwa@concourt.org.za), being Ms Mthethwa's own email address. Ms Pisanti did so. A copy of this email is annexed marked "TJB5".

14 Ms Mthethwa thereafter confirmed receipt of Ms Pisanti's email marked "TJB5".

15 At 14h08, Ms Pisanti received an email from Ms Mthethwa indicating that -

*"We acknowledge receipt of your email below.*

*Kindly note that your Application was filed out of time and cannot be processed.*

*You are herein required to file a condonation application for the late filing".*


16 A copy of Ms Mthethwa's email is annexed marked "TJB6".

17 Shortly after receipt of Ms Mthethwa's email, Ms Pisanti contacted Ms Mthethwa to enquire why her email recorded that the Application was filed late in circumstances were Mr Boswell transmitted the Application on 5 February 2026.

18 Ms Mthethwa indicated that Mr Boswell's email of 5 February 2026 had been sent to generaloffice@concourt.org and not generaloffice@concourt.org.za and therefore she regarded it as only having been received on 6 February 2026, upon receipt of Ms Pisanti's email. Consequently she required the applicants to apply for condonation.

19 The error above was a genuine administrative error, for which I sincerely apologise. I respectfully submit that there can be no prejudice to any of the parties in the event that condonation for the registration of the Application is granted.

## THE APPLICATION AND PROSPECTS OF SUCCESS

- 21 This case concerns the proper interpretation of the business rescue provisions in Chapter 6 of the Companies Act, 2008 ("Companies Act"). In particular, it raises novel questions regarding the meaning of section 136(2)(a) of the Companies Act, and the extent to which it applies to the written Sugar Industry Agreement, 2000 ("the SI Agreement"), which was published under the Sugar Act, 1978 ("the Sugar Act").
- 22 The issues arising for determination in the proposed appeal are of particular importance in a number of spheres, are novel and require definitive pronouncement from this Court.
- 23 I respectfully submit that there are reasonable prospects that this Court will reach different conclusions on one, or more, or all of these conclusions – and reverse the SCA's findings and order on appeal. The grounds on which leave to appeal is sought are articulated in the application for leave to appeal.

## CONCLUSION


